#### 1. Regular Meeting Called to Order-Chair

Meeting called to order by chairman, Dale Wilson at 1:30 P.M. he noted that this is a regular meeting held in compliance with the Oklahoma Open Meeting Act, Title 25 of the Oklahoma Statutes, Sections 301 and following, as amended. Notice of this meeting is on file with the county clerk's office. The agenda for this meeting was posted at 11:25 A.M. on January 4, 2022 at the front entrance of the district office and district website.

#### 2. Consideration and Possible Action on the following items:

#### 3. Rene Crispin, Barnitz #12 – discussion with board over fencing

The chairman asked Mr. Crispin if he wanted to present his case on the fencing on Barnitz #12. Mr. Crispin started with the district website that states helping promote conservation on the land and cooperating with landowners. The Crispin's have only owned the land approximately 800 days and have worked hard on this property to improve from the last owner. In July 2019, Rene meets with Jason and Paul to look at cleaning up trees, plowing up and reseeding to grass. Then Jason comes and visits him about putting up fence. Crispin's have a grazing cattle operation and grass is important to them. Rene said they have cleaned up old fence from where the site fence has not been maintained. Crisping commented the fence had been abandoned. Stewart, OCC council said the fence and structure had not been abandoned. It is the district that is liable for the site if maintenance is not provided. So, it is the districts job to oversee issues. Bratten interjected that the district has an NRCS waiver on the structures if vegetation is adequate that fencing doesn't have to be in place. This site was already being monitored before the Crispin's purchased it. The district said that the old fence can be cleaned up. It is normally done on request from the landowner. Then Crispin talked about the marsh where water stood behind the dam to highway 47 and trees on the site. Bratten stated that the trees are cleared 20 feet from back of the dam. The water problem could be looked at since most of the highway boxes under the highway are usually higher than the natural flow. We can have ODOT come and look at the drainage boxes under the highway. Bratten ask Crispin how he did his grazing with cattle. He rotational grazes. So, the board and all present discussed how fencing could be put up to satisfy the problem with both the Crispin's and the board. After reviewing maps and discussion a plan was laid out to fence around the dam and spillway and take fence to the highway south. There would be gates on both ends of the dam (2–12-foot gates to clear equipment to cross). A 10-foot gate would be added on the

east side near the highway so the district could get entry to maintain back side of the dam. There were some more trees that the district can clear near the east side of dam on the back side, which is where brush is stored when cleaned off to burn. Mr. Crispin asked what happened when the fence doesn't help the vegetation on the back of the dam. Stewart, OCC council said then other steps will have to be taken to solve the problem. The district might have to request engineer to do a site visit and determine why the vegetation can't be established. It was agreed that Paul and Jason would meet Rene on site when staking fence to work with the landowner on fencing. Crispin thanked the board for the opportunity to state his case. Marks made a motion to approve the fencing arrangement with Crispin's, seconded by Salisbury. Aye votes: Marks, Salisbury, Emmons, Ommen, and Wilson. Nay votes: none. The Crispin's left the meeting.

Bratten talked about available training for district employees on conservation planning through NCDEA. She had visited with Gary O'Neil, Trey Lam, and Lisa Knauf by email. It is a fast turn around and must be done by September to get funds. She is preparing paperwork for the audit. Keith is still not doing

well so I am having to drive him everywhere. We are either in a doctor's office or in the ER about every other day right now. He spent July 1-July 4 in Baptist hospital, so hopefully things will get better. C-NRCS

Tune reported he had been working on CRP grass planting and spent a week in Guymon working on CRP. Jeremy Hughes reported the office was working on program contracts.
